

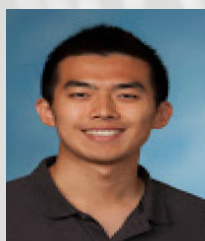

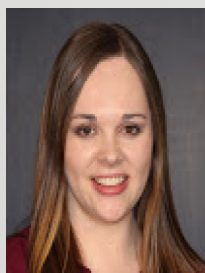

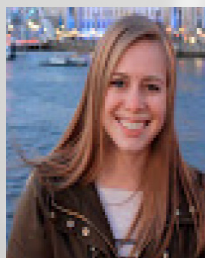
Ping Chiu
